This Indenture made this 2nd day of March in the year Lorded one thousand eight hundred and twenty six Between Bron Orsborn of the County of Clermont and State of Ohio of the one part and John K. Morris of the County and State aforesaid of the other part Witnesseth that the said Bron Orsborn for and in consideration of the sum of seventy five Dollars to him in hand paid the receipt whereof is hereby acknowledged hath granted bargained and sold and by these presents doth grant bargain and sell with Covenant and confirm to the said John K. Morris his heirs and assigns for ever the following described tract or parcel of land in State Township County and State aforesaid being a part of John B. Rackeridge's survey of 4000 acres Tract of Entry 2373 and bounded as followeth to wit beginning at a stake seven poles N. 33 E. of a gum maple & Elm thence North thirty three degrees East eighty two poles to a white oak and two white oaks & N. 88 W. 1/2 line thence with this line S. 88 1/2 E. 135 poles to two maples again on the line of said white thence South thirty three degrees East thirty two poles to stake near a sweet gum on the North side of the Road thence with the road S. 88 W. seven poles N. 33 E. 6 poles N. 73 W. 50 poles N. 71 1/2 W. 46 poles N. 78 1/2 W. 26 poles to beginning containing fifty acres more or less Together with all and singular the profits and Commodities therunto coming or in any wise appertaining and the said Bron Orsborn for himself his heirs Executors and administrators doth Covenant and agree that the above described premises with the appurtenances therunto belonging he will forever warrant and defend to the said John K.
