wills by me at any time heretofore made.


And as to my worldly estate, and all the

shall be entitled at the time of my decease,
I devise, bequeath and dispose thereof
in the manner following, to wit:

Imprimis. My will is, that all my just debts
and funeral charges shall, by my executors
hereafter named or appointed, be paid
out of my estate, as soon after my decease
as shall by them be found convenient.

Item. I give, devise, and bequeath to my
beloved wife Rebecca Osman all of my
worldly estate and all the property, real, personal,
or mixed of which I shall die seized and
possessed, so long as she shall remain un-
married, and my widow, whom I hereby
appoint sole executrix of this my last
will and testament.

November, in the year of our Lord One
thousand Eight hundred and Seventy
two.
