I William osborn of the township of Boardman and of the County of Mahoning and of the State of Ohio I do make and Publish this my Last Will and testament in maner and form following that is to say

First it is my will that my funereal expences and all my Just debts be fully paid

Second I Give and Devise and Bequath to my Beloved Wife Elizabeth osborn in Line of her Dower the plantation on which We now Resid containing a beut Seventy Nine Acres Situat in Lot No 7 Seven and also one other Lot in Lot No 5 five and in Rang No 4 and 5 containing one hundred and fore Acres in the two Lot to have the use of the two tract During her Nattheral Live tim and also two hundred Dollars out of the first money of my Estat and also two Cows and six Sheep ~~and~~ all the house hold furniture and all the Beds and all the Bleathing Belong to the family During her Nattheral Live tim and all the Stoves and all the Chicken Ware

third I Give <sup>and Devise</sup> to the following Named Persons the following Summe of money Mary Ann Ritter Eighty Dollars Elizabeth L Ritter Eighty <sup>Dollars</sup> William Warren osborn Eighty Dollars John A osborn fifty Dollars James Thatfield fifty Dollars Mary Ann Wancemaker forty Dollars and Margrat Mc Cortel twenty five Dollars
