### Truman Parmely Dec<sup>d</sup>

Ordered that William Jean be appointed Guardian to James and Ira Parmely until they respectively arrive to the age of twenty one years minors and children of Truman Parmely late of Berlin deceased To give bond with surety in the penal sum of three hundred dollars Henry Cook is accepted as his surety they made choice of the said William as their Guardian as certified to the Court.

### Daniel Fink Dec<sup>d</sup>

This day the Executor on the Estate of Daniel Fink deceased filed a final settlement Ordered that the same remain on file until the next Term for exceptions &c.
