Ordered that the Executors of E. S. Benton have further time for one year to make a final settlement.

### John Strong Dec<sup>r</sup>

Ordered that John Schuff be appointed Administrator in the estate of John Strong late of <sup>deceased</sup> to give bond with Samuel Moore and Bazzell Porter as sureties in the penal sum of six hundred dollars.

Ordered that John Nolan and John Collman be appointed appraisers of personal property. The widow declines Administration as certified to the Court.

### Mary S Huntington Dec<sup>r</sup>

This day the last Will and testament of Mary S Huntington is produced in Court and Andrew Fitch and John C. Trullman the subscribing witnesses to said Will having at the last term of said Court appeared in open Court and made oath that they saw the said testator subscribe said Will and that at the time of subscribing the same he was of full age of sound mind and memory and not under any restraint, and that they subscribed the said Will as witnesses to the same in the presence of the said testator, and in the presence of each other.

Then B. Fitch, the Executor named in said Will now appears and accepts the trust, and is sworn as such Executor, to give bond in the sum of two thousand dollars with Richard Fitch and John C. Trullman as sureties. Ordered that Joseph and Samuel Bingham and Andrew Fitch be appointed appraisers of personal property, and that said Will and probate be recorded.
