I Give & beque unto my wife nd Mary Platt one Shilling to be paid by nd Edw Osborn.

I Give & beque unto Tabitha Osborn my bed & what is belonging to it.

I Give & beque unto nd Edw Osborn everything else that properly belongs to me for & in consideration of his trouble & Care he hath taken of me in my sickness. to the true & honest performanc of which I have here unto sett my hand & Seal this 10th day of Apr 1692
