Be it remembered that this day the foregoing Settlement was made as shown above. The receipts for payment to the heirs are given jointly to W^m Osburn as adm^r of Thomas Osburn & to Geo Osburn adm^r of Priscilla Osburn and in order to equalize the Amts as paid by each one, I divided the receipt *pro rata* according to the funds found in the two Amts hands due the two estates - the receipts are filed in the Settlement of Thos Osburns estate. Given under my hand this 8th day of May 1861.
